Letter From Your President

I hope you and your family are well and enjoying a wonderful springtime in New Mexico. It has been an exciting past few months for RPENM and I am pleased with our accomplishments. Much of this newsletter deals with an attempt to pass a bill during the last legislative session that would have eliminated the New Mexico Retiree Health Care Authority.

RPENM worked tirelessly during the session to successfully defeat that bill. Board members Oscar Jordan, Ann Crandall, Rick Mack and Isabel Clendenin, as well as Executive Director Doug Crandall deserve a *special thank you* from all of us for the hard work they did on our behalf. In addition, the Association of Educational Retirees, (NMAER) lead by President Marge

Lancaster and Executive Director Russell Goff worked hand-in-hand with RPENM in order to assure the continued existence of NMRHCA as a nonpolitical, independent organization.

As successful as we were, though, I was disappointed more that members. especially from the Albuquerque and Santa Fe area did not get involved by going to the legislature. This issue of eliminating NMRHCA affects all of us and it will be brought up again during the next legislative session. if not sooner. It is imperative that we all get involved to protect our health care!

I have reluctantly accepted the resignation of Doug Crandall as our

RPENM & AER Join Forces To Protect Health Care

Everyone knows the old adage about strength in numbers. This is especially true in politics. As a result, RPENM has teamed up with the Association of Educational Retirees to assure the future of the New Mexico Retiree Health Care Authority as an independent agency.

team approach worked spectacular fashion during the last legislative session when we defeated two companion bills, House Bill 561 and Senate Bill 538. This legislation was intended to eliminate NMRHCA and include it as part of an omnibus health care authority combining all state Public Schools employees, the Insurance Authority and the Albuquerque Public Schools.

The proposed legislation would have created an unwieldy 30 person board, twenty-five of who would be voting members. The Governor would have

appointed fourteen of the 25 voting members. RPENM's representation on the board would have been eliminated entirely!

Working together with AER, the Governor and legislators received over 16,000 telephone calls, e-mails and

letters in opposition to the proposal. Over 80 RPENM and AER members packed the meeting room of the Budget and Appropriation committee hearing room to speak out against the legislation, which was finally tabled on the last day of the session.

At issue here is the politicization of our retiree health care. We believe that, in 1990, Governor Carruthers and the New Mexico State legislature made a promise to ERA and PERA retirees to provide a non-political health care authority to oversee the health and well

being of its members. We expect the current and future governors, as well as the current and future legislatures to honor that promise.

Unfortunately, our work is not done. There are rumors of a special legislative session this summer to deal with the health care issue again, and Governor Richardson has made it clear that he has placed this issue on the top of his agenda. RPENM and AER will be interviewing legislative candidates and making our voices heard before this issue is re-introduced.

Kudos To Oscar Jordan

RPENM Board member Oscar Jordan deserves a special thank you from all NM Retiree Health Care members. Oscar, almost single-handedly at times, monitored the progress of SB 538 and HB 561 to make sure that we had a voice any time the bills were heard. Elections are also underway for the retiree position on the PERA Board. Incumbent Jerry Rael and ex-officio RPENM Board member is seeking re-election. Other RPENM members who expressed an interest in running include RPENM Board member Wesley Brown and former Bernalillo County Sheriff Joe Bowdich. Ballots will be mailed to all PERA retirees in

August.

PERA assets reached the \$9.5 billion mark in March. Returns for 2003 exceeded 23%, the second highest annual increase in the history of the fund! While retirement plans around the country are struggling, PERA remains strong and sound.





NMRHCA Switch Enrollment Meetings

All PERA retirees receiving Retiree Health Care Benefits were notified by mail in March 2004 that the upcoming Switch Enrollment period for health care plans is soon to be in effect. During switch enrollment, members may switch medical plans and/or dental options and add dental or vision coverage (unless you dropped an NMRHCA dental or vision plan in the last four years). This Switch Enrollment time frame is the only period during which these changes may be made. Changes in coverage will take effect July 1, 2004. It is important that interested parties attend a switch enrollment meeting in various parts of the state as noted in the schedule sent by mail to all NMRHCA members. If you do not have the date and time of a meeting in your area, contact NMRHCA at 1-800-2332576 for information.

Milton Sanchez, Director of NMRHCA, has given RPENM approval to recruit new membership at switch enrollment meetings. Executive Director Doug Crandall sent notification of this opportunity to all RPENM Board Members and Chapter Chairs. Last year, approximately 20 new members were recruited statewide from this endeavor, and hopefully, we will sign up even more members this year! Mr. Sanchez has also agreed to allow an RPENM representative address those attending the switch enrollment meeting to explain the important reasons for becoming a member of RPENM. Use this opportunity in your area to sign up new RPENM members!
