# **BY LAWS CHANGES TO BE VOTED ON AT MEETING**

# **Rep. LARRANAGA INTRODUCES "DOUBLE DIPPING" BILL**



Albuquerque state representative Larry Larranaga introduced a bill during the last legislative session that would have restricted "double dipping" from retired PERA employees, Although this bill had great support, and the support of RPENM, it was not passed due to the short session. Although the original intent of the so called "return to work" bill was to retain employees in the public safety area, the vast majority of the over 1300 retirees who have gone back to work are not in public safety related positions. We feel that the double dipping will eventually erode the soundness of the PERA fund and we strongly support Representative Larranaga and hope that he will introduce a similar bill in the 2007 legislative session. ■

### **BETTY BOXX PASSES AWAY**

On a sad note, long time RPENM Board member Betty Boxx passed away on February 21, 2006. She had been an active RPENM member and board member for many years. In addition to serving on the RPENM Board, she was also a member of the Chapter 5 board. ### **TREASURER'S REPORT** I want to start by thanking all of the RPENM members that supported last year's

members that supported last year's increase in dues. That support, for the first time in two years, will allow us to complete 2006 without having to draw from our investment account in order to pay the bills.

In fact, we ended 2005 with a balance of \$30,594.63 in our checking account and an increase in our investment account of \$622.88 (interest earned between 6/30/05 and 12/31/05) for a balance of \$51,970.01.

The increase in income will allow us to acquire an office and to conduct a state wide membership drive, both goals that we would not have been able to attempt without the increase.

I'd also like to extend RPENM's thanks to the firm of Schlenker, Cantwell and Hrncir

and their representative, Michelle Linehan Pierce for all the work they do for us in the areas of payroll, tax form preparation and general support for our group.

I'd also like to thank attorney Thomas F. Hooker Jr. for reviewing our proposed By Laws changes and Chapter Guidelines. His work in this area will ensure that the changes we are proposing to the membership meet all legal criteria.

In ending, again, thanks to all of you that understood the need for the dues increase and showed your support by retaining your membership. Without this support, RPENM would have ceased to function sooner rather than later. ■
