Retiree Health Care Update

I am pleased to report that the New Mexico Retiree Health Care Authority remains strong and well positioned to meet the continuing needs of New Mexico's retired public and educational employees.



RHCA finances remain strong with over \$430 million in the trust fund despite a very volatile stock market. Despite the market gyrations, the Authority's investment portfolio was well positioned to avoid any significant losses. In addition, over \$170 in contributions have been added to the plan since 2010. This strong financial position ensures plan solvency for at least 20 years.



Several new vendors bid for next year's RHCA medical, dental and vision plans. Regardless of which companies may be chosen, this is good news, as competition is good for both competitive rates and services offered.

A request to increase employee and employer rates will likely be introduced again in this year's 2016 legislative session, though once again it is unlikely to pass. These increases are necessary to assure RHCA's long term solvency, but it is also quite clear that the New Mexico economy makes any contribution increase burdensome on both employees and employers. The RHCA Board has made several changes which have decreased benefits and subsidies over the past five years. These reductions have played a large part in the solvency gains of the plan. However, there comes a point where too many cuts will no longer provide a meaningful health care plan.

One plan design that does remain an option is to require a waiting period for someone who has voluntarily dropped RHCA medical coverage when in good health and then wants to re-enroll after encountering a medical problem. Though few eligible members do this, it can be quite costly to the trust fund and overall financial status of the plan. This option will be discussed by the Board in 2016.

An affordable and comprehensive health insurance plan assures that there will be adequate coverage available when it is needed. Another important part of any health plan is wellness. Sometimes diseases cannot be avoided. You may have been born with a congenital condition which cannot be cured, but only controlled. Some diseases are eminently preventable, such as lung or heart problems as a result of an unhealthy lifestyle. In either case, RHCA and its medical partners offer not only wellness programs, but actual wellness incentives such as a cash gift card for enrolling and completing a wellness program. Whether it is assuring that you take your medication on time and as needed, or adopting a healthier lifestyle by losing weight or quitting smoking, RHCA has a program available. Please become acquainted with the wellness benefits of your health plan.


Volunteer tax preparers are available to meet with residents at more than 25 locations across the state
